## **BOONE COUNTY ORDINANCE 111**

AN ORDINANCE PRECRIBING BOONE COUNTY VOTING PRECINCTS EFFECTIVE  
JANUARY 15, 2012, IN ACCORDANCE WITH IOWA LAW, BASED ON THE 2010 CENSUS.

### **Section 1: Purpose**

Voting precincts located in Boone County are hereby redrawn based on the 2010 U.S. Census. The new precinct lines become effective January 15, 2012 and remain effective until revised by the 2020 U. S. Census.

The Boone County voting precincts are described generally as follows:

Boone 1	As established by City of Boone
Boone 2	As established by City of Boone
Boone 3	As established by City of Boone
Boone 4 and Des Moines Tnsp	As established by City of Boone and County of Boone by a precinct agreement dated 8-31-2011 / 9-2-11
Boone 5	As established by City of Boone
Madrid 1	As established by City of Madrid
Madrid 2	As established by City of Madrid
Madrid 3	As established by City of Madrid
Ogden	All of City of Ogden
Rural Precinct 1	Colfax Township excluding City of Luther; Garden Township including that part of City of Sheldahl in Boone County and excluding City of Madrid;
Rural Precinct 2	Cass township, Douglas Township except City of Madrid, Worth Township including City of Luther
Rural Precinct 3	Peoples Township; Union Township including City of Berkley
Rural Precinct 4	Amaqua Township including City of Beaver; Beaver Township excluding City of Berkley; Marcy Township excluding City of Ogden; and Yell Township excluding Cities of Fraser and Ogden
Rural Precinct 5	City of Fraser; Grant Township including the City of Boxholm; and Pilot Mound Township including the City of Pilot Mound

Rural Precinct 6      Dodge Township except City of Frasier; Harrison Township;  
Jackson Township

Each of the above-described precincts will have one voting place as established by the Boone County Auditor in compliance with all applicable federal and state laws.

## **Section 2: Voting Precinct Boundaries Defined**

**Boone 1 Precinct:** All that portion of the City which lies within the area described as beginning at the intersection of the centerlines of Sixth Street and Marshall Street; thence north on centerline of Marshall Street to the centerline of Seventh Street; thence West to the centerline of Story Street; thence north to the centerline of Fourteenth Street; thence east to the centerline of Marshall Street; thence north to the centerline of Twenty-second Street; thence east to the north quarter corner of Section 22-84-26; thence southerly along the easterly corporation limits to the centerline of Mamie Eisenhower Avenue; thence westerly along the centerline of said Mamie Eisenhower Avenue to the centerline of Linn Street; thence north to the centerline of Fifth Street; thence west to the centerline of Marshall Street; thence north to the point of beginning, shall constitute and is denominated the first ward of the City.

**Boone 2 Precinct:** All that portion of the City which lies within the area described as beginning at the intersection of the centerlines of Union Street and Marshall Street; thence east to the centerline of South Linn Street; thence north to the centerline of Mamie Eisenhower Avenue; thence easterly along the centerline of said Mamie Eisenhower Avenue to the easterly corporation limits at the center Section 27-84-26; thence southerly along the easterly corporation limits to the south corporation limits at the southeast corner of the northwest fractional quarter of Section 2-83-26; thence west along the south corporation limits to the centerline of South Story Street; thence northerly along the centerline of said South Story Street to the centerline of Primary Road No. U.S. 30; thence east to the centerline of South Marshall Street extended; thence north to the point of beginning, shall constitute and is denominated the second ward of the City.

**Boone 3 Precinct:** All that portion of the City which lies within the area described as beginning at the intersection of the centerlines of Sixth Street and Marshall Street; thence south along the centerline of Marshall Street to the centerline of Fifth Street; thence east to the centerline of Linn Street; thence south to the centerline of Union Street; thence west to the centerline of Marshall Street; thence south to the centerline of Primary Road No. U.S. 30; thence west to the centerline of South Story Street; thence south along the centerline of South Story Street to the south corporation limits; thence west to the west quarter corner of Section 4-83-26; thence northerly along the westerly corporation limits to the intersection of the centerlines of South Division Street and Park Avenue; thence north to the centerline of Sixth Street; thence east to the point of beginning, shall constitute and is denominated the third ward in the City.

**Boone 4 Precinct and Des Moines Township:** All that portion of the City which lies within the area described as beginning at the intersection of the centerlines of Sixth Street and Marshall Street; thence west to the centerline of Division Street; thence north to the centerline of West Tenth Street; thence west to the centerline of State Street; thence north to north corporation limits at the centerline of West Twelfth Street; thence northeasterly along the northwesterly corporation limits to the centerlines of Division Street and Twenty-second Street; thence east to the centerline of Marshall Street; thence south to the centerline of Fourteenth Street; thence west to the centerline of Story Street; thence south to the centerline of Seventh Street; thence east to the centerline of Marshall Street; thence south to the point of beginning, shall constitute and is denominated the fourth ward in the City. By city county precinct agreement rural residents of Des Moines Township will vote at polling place of Boone Precinct 4 in primary and general elections or any county-wide special election. **Des Moines Township** is described as beginning at the intersection of "S" Ave. and 220<sup>th</sup> St, North along centerline of "S" Ave. to intersection of center line of 160<sup>th</sup> Street, thence west along the centerline of 160<sup>th</sup> Street until intersection of centerline of the Des Moines River, thence southerly along centerline of Des Moines River until its intersection with centerline of 220<sup>th</sup> Street, thence east along the centerline of 220<sup>th</sup> Street until it intersects the SW corner of City of Boone, thence beginning northerly and following City of Boone city limits until the easterly boundary intersect with the centerline of 220<sup>th</sup> Street, then easterly along centerline of 220<sup>th</sup> Street to the point of beginning.

**Boone 5 Precinct:** All that portion of the city which lies within the area described as beginning at the intersection of the centerlines of Sixth Street and Division Street thence north along the centerline of Division Street to the centerline of Tenth Street, thence west along the centerline of Tenth Street to the centerline of State Street, thence north on the centerline if State Street to north city limit, thence west along north city limit to west city limits, thence south along west city limit line to centerline of Park Avenue, thence east along southerly city limit line to centerline of Division Street, thence north on centerline to point of beginning point of beginning, shall constitute and is denominated the fifth ward in the City of Boone.

**Madrid 1 Precinct:** All that portion of City of Madrid that lies within the area described as beginning at the centerline of State Highway 17, also known as Kennedy Avenue, at a point where it meets the north corporate limits of Madrid, Iowa; thence east along the northerly corporate limits to the easterly corporate limits; thence southerly along the easterly corporate limits to the south corporate limits; thence west along the south corporate limits to the centerline of State Highway 17; thence north along the centerline of State Highway 17 to the centerline of the High Trestle Trail (southern edge of census block 190150205001092); thence west along the centerline of the High Trestle Trail to State Street; thence north along State Street to 2<sup>nd</sup> Street; thence east on 2<sup>nd</sup> Street to Union Street; thence north along Union Street to 22<sup>nd</sup> Street; thence east along 22<sup>nd</sup> Street to Newton Road; thence north along Newton Road to Maple Ridge Drive; thence east along Maple Ridge Drive to State Highway 17; thence north along State Highway 17 to the point of beginning, shall constitute and is denominated the first ward in the City of Madrid.

**Madrid 2 Precinct:** All that portion of the city which lies within the area described as beginning at the centerline of State Highway 17, also known as Kennedy Avenue, at a point where it meets the north corporate limits of Madrid, Iowa; thence south along State Highway 17 to Maple Ridge Drive; thence west along Maple Ridge Drive to Newton Road; thence south along Newton Road to 22<sup>nd</sup> Street; thence west along 22<sup>nd</sup> Street to Union Street; thence south along Union Street to 2<sup>nd</sup> Street; thence west along 2<sup>nd</sup> Street to State Street; thence south along State Street to the centerline of the High Trestle Trail (southern edge of census block 190150205001092); thence east along the centerline of the High Trestle Trail to State Highway 17; thence south along State Highway 17 to the south corporate limits; thence west along the south corporate limits to S. Main Street; thence north along S. Main Street to 7<sup>th</sup> Street; thence east along 7<sup>th</sup> Street to S. Water Street; thence north along S. Water Street to 5<sup>th</sup> Street; thence west along 5<sup>th</sup> Street to Main Street; thence north along Main Street to 22<sup>nd</sup> Street; thence east along 22<sup>nd</sup> Street to N. Water Street; thence north along N. Water Street to the north corporate limits; thence easterly, northerly, and easterly along the northern corporate limits to the point of beginning shall constitute and is denominated the second ward in the City of Madrid.

**Madrid 3 Precinct:** All that portion of the city which lies within the area described as beginning at the intersection of N. Water Street and the north corporate limits; thence south along N. Water Street to 22<sup>nd</sup> Street; thence west along 22<sup>nd</sup> Street to Main Street; thence south along Main Street to 5<sup>th</sup> Street; thence east along 5<sup>th</sup> Street to S. Water Street; thence south along S. Water Street to 7<sup>th</sup> Street; thence west along 7<sup>th</sup> Street to S. Main Street; thence south along S. Main Street to the south corporate limits; thence westerly, northerly, and easterly along the corporate limits to the point of beginning, shall constitute and is denominated the third ward in the City of Madrid.

**Ogden Precinct:** Bounded by the city limits of the City of Ogden, Iowa.

**Rural Precinct 1:** Generally described as Colfax Township excluding Luther, Garden Township including that part of City of Sheldahl in Boone County and excluding the City of Madrid. Bounded as follows; beginning at the intersection of centerlines of "Y" Avenue and 340<sup>th</sup> Street thence north along centerline of "Y" Avenue to the centerline of "220<sup>th</sup>" Street, thence west on centerline of 220th Street or a line projected there-from to centerline of "S" Avenue, thence south on centerline of "S" Avenue to the northern city limits of the City of Luther, thence easterly, southerly, and westerly around the city limits of Luther to the centerline of "S" Avenue, thence south on centerline of "S" Avenue to the northern city limits of Madrid, thence easterly, southerly, and westerly along City of Madrid's northern boundary, thence easterly, southerly and westerly until city limits to the centerline of "S" Avenue, thence south on "S" Avenue to centerline of "340<sup>th</sup>" Street, thence east on centerline of "340<sup>th</sup>" Street to point of beginning, shall constitute and is denominated Rural Precinct 1 in Boone County, Iowa.

**Rural Precinct 2:** Generally described as Cass Township, Douglas Township excluding the City of Madrid and Worth Township including the City of Luther. Bounded as follows, beginning at the intersection of centerlines of "S" Avenue and 340<sup>th</sup> Street or a line projected there from north on the centerline of "S" Avenue to the southern limit of the City of Madrid, thence westerly, northerly, and easterly along the city limits of Madrid to the centerline of "S" Avenue, thence north on the centerline of "S" Avenue to southern limits of City of Luther, thence east, north, and west along City of Luther's easterly limits until intersection with center line of "S" Ave., thence north along centerline of "S" Ave. until it intersects with the centerline of 220<sup>th</sup> Street, thence west to City of Boone easterly city limit, thence south, west and north around southerly city limits of Boone until intersects centerline of 220<sup>th</sup> Street, thence west to intersection of centerline of Des Moines River, thence southerly and easterly along centerline of Des Moines River until it intersects with centerline of 280<sup>th</sup> Street, thence west on centerline of 280<sup>th</sup> Street or a line projected there from to centerline of "M" Avenue, thence south on centerline of "M" Avenue or a line projected there from to the centerline of 340<sup>th</sup> Street or a line projected there from, thence east along centerline of 340<sup>th</sup> Street or a line projected there from to point of beginning, shall constitute and is denominated Rural Precinct 2 in Boone County, Iowa.

**Rural Precinct 3:** Generally described as Peoples Township, Union Township including Berkley. Bounded as follows, beginning at the intersection of the centerlines of 340<sup>th</sup> Street or a line projected there from and "M" Avenue thence north along the centerline of "M" Avenue or a line projected there from to its intersection with the centerline of 280<sup>th</sup> Street, thence west on the centerline of 280<sup>th</sup> Street or a line projected there from to the east city limit of Berkley, thence northerly, westerly and southerly along the city limits of the City of Berkley to the intersection of the west city limit with the centerline of 280<sup>th</sup> Street, thence west on 280<sup>th</sup> Street to the centerline of "A" Avenue or a line projected there from, thence south along the centerline of "A" Avenue to its intersection with the centerline of 340<sup>th</sup> Street or a line projected there from, thence east on centerline of 340<sup>th</sup> Street to point of beginning, shall constitute and is denominated Rural Precinct 3 in Boone County, Iowa.

**Rural Precinct 4:** Generally described as Amaqua Township including Beaver, Beaver Township excluding Berkley, Marcy Township excluding Ogden, and Yell Township excluding Cities of Fraser and Ogden. Bounded as follows; beginning at the intersection of centerlines of 280<sup>th</sup> Street or a line projected there from and the centerline of the Des Moines River, thence northerly along the centerline of the Des Moines River to city limits of the City of Fraser, thence westerly and northerly along the city limits of Fraser to its intersection with the centerline of 160<sup>th</sup> Street or a line projected there from, thence west on centerline of 160<sup>th</sup> Avenue or a line projected there from to its intersection with the centerline of "A" Avenue, thence south on the centerline of "A" Avenue or a line projected there from to the intersection of the centerline of 280<sup>th</sup> Street, thence east along centerline of 280<sup>th</sup> Street to the west city limits of the City of Berkley, thence north, east and south along the city limits of Berkley to the intersection of the centerline of 280<sup>th</sup> Street, thence east along the centerline of 280<sup>th</sup> Street or a line projected there from to point of beginning, except that part of Yell and Marcy Townships within the city limits of the City of Ogden, shall constitute and is denominated Rural Precinct 4 in Boone County, Iowa.

**Rural Precinct 5:** Generally described as the City of Fraser, Grant Township including the City of Boxholm, and Pilot Mound Township including the City of Pilot Mound. Bounded as follows; beginning where the centerline of the Des Moines river intersects the southeast city limits of the City of Fraser, thence easterly, northerly and westerly around the city limits of Fraser to the centerline of the Des Moines river on north Fraser city limit, thence northerly along the centerline of the Des Moines river to the centerline of 100<sup>th</sup> Street or a line projected there from, thence west on the centerline of 100<sup>th</sup> Street or a line projected there from to the centerline of "A" Avenue, then south along the centerline of "A" Avenue or a line projected there from to the centerline of 160<sup>th</sup> Street, thence east on the centerline of 160<sup>th</sup> Street or a line projected there from to the west city limits of the City of Fraser, thence southerly and easterly along said city limits to point of beginning, shall constitute and is denominated Rural Precinct 5 in Boone County, Iowa.

**Rural Precinct 6:** Generally described as Dodge Township except City of Frasier, Harrison Township, and Jackson Township. Bounded as follows, beginning at the intersection of the centerlines of 220<sup>th</sup> Street and "Y" Avenue, thence north on the centerline of "Y" Avenue or a line projected there from to centerline of 100<sup>th</sup> Street, thence west on centerline of 100<sup>th</sup> Street or on a line projected there from to centerline of Des Moines River, thence southerly along the centerline of the Des Moines river to north city limits of the City of Fraser, thence easterly, southerly, and westerly along city limits of Fraser to center line of the Des Moines river on easterly border of said city, thence southerly along the centerline of Des Moines river until it intersects the centerline of 160<sup>th</sup> Street or a line projected there from, thence east along centerline of 160<sup>th</sup> street or a line projected there from to the intersection of centerline of "S" Ave, thence south along centerline of "S" Ave or a line projected there from until intersection of centerline of 220<sup>th</sup> Street, thence east on centerline of 220<sup>th</sup> Street or a line projected there from to point of beginning shall constitute and is denominated Rural Precinct 6 in Boone County, Iowa.

### **Section 3: Repealer**

All ordinances in conflict herewith are repealed.

### **Section 4: Severability Clause**

If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity or the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

**Section 5: When Effective**

This ordinance shall be in effect after its passage, approval and publication as provided by law.
