ORDINANCE NO. 122

ORDINANCE AMENDING THE OFFICIAL BOONE COUNTY ZONING MAP

LEGAL DESCRIPTION: That portion of the NE ¼ of NE ¼ and SE ¼ of NE ¼ of Section 14 T83N-R27W Marcy Township located east of L Ave and owned by Craig A. and Roylene Shepley. (27.48 acres, which includes 2.41 acres of existing public right of way.) A detailed legal description of property may be found Book 2002 Page 228 in the office of the Boone County Recorder. * A map of area is attached.

WHEREAS, Craig A. Shepley will rezone of 25.54 acres, more or less, located approximately 4.5 mile from the City of Boone from A-1 (Agricultural Conservation District) to TA-1 (Transitional Agricultural District). See *Exhibit A. The site is located in Marcy Township, County of Boone, Section 14, T83N, R27W. Rezoning is necessary in order to accommodate the Butternut Woods Estates, a minor residential subdivision, and two existing residential homes.

WHEREAS, at certain times it is necessary to clarify or change the language of the Zoning Ordinance in order to make regulations more proficient in addressing issues of growth and desires of the citizens. It is also necessary to clarify the ordinance to make it organized and easier to understand.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF BOONE COUNTY, IOWA AS FOLLOWS:

SECTION ONE: That Boone County shall, and it does hereby, approve an amendment to the Official Zoning Map that the property (See *Exhibit A) be rezoned from A-1 Agricultural Conservation District to TA-1 Transitional Agricultural District

SECTION THREE: That this amendment shall be in full force and effect from and after its passage and approval in the manner provided by law.
