ORDINANCE NO. 123

ORDINANCE AMENDING THE OFFICIAL BOONE COUNTY ZONING MAP

LEGAL DESCRIPTION.

Parcel 'A' of N.E. ¼ N.W. ¼ Sec. 12-83-26, West of the 5th P.M., Boone County, Iowa, as recorded in Plat Book 33, Page 27, in the office of the Recorder of Boone County, Iowa.

WHEREAS, Stephen Riker applied for the rezoning of 3.53 acres, more or less, from A-1 Agricultural Conservation District to R-1 Rural Estates Residential District.

WHEREAS, at certain times it is necessary to clarify or change the language of the Zoning Ordinance in order to make regulations more proficient in addressing issues of growth and desires of the citizens. It is also necessary to clarify the ordinance to make it organized and easier to understand.

WHEREAS, the Director of Planning and Development forwarded a recommendation for approval to the Boone County Zoning Commission. The Zoning Commission held a public hearing on Monday, November 25, 2013 in accordance with Iowa Code and has forwarded a Final Report to the Boone County Board of Supervisors recommending approval of Stephen Riker's petition to rezone 3.58 acres, more or less, from A-1 Agricultural Conservation district to R-1 Rural Estates Residential District to accommodate two existing dwellings. One dwelling is owned by Stephen Riker. The second dwelling is owned by Stephen Riker's son, Marc.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF BOONE COUNTY, IOWA AS FOLLOWS:

SECTION ONE: That Boone County shall, and it does hereby, approve an amendment to the Official Zoning Map that the property (*See Exhibit A) be rezoned from A-1 Agricultural Conservation District to R-1 Rural Estates Residential District
