### ORDINANCE AMENDING THE OFFICIAL BOONE COUNTY ZONING MAP

#### LEGAL DESCRIPTIONS:

PIN 08 8325 10 12 50 002 DESCRIBED as Lot 1 Clear Creek Commons 2<sup>nd</sup> Addition, a part of Parcel "A" in the Northwest 1/4 of the Northeast 1/4 of Section 10, Township 83 North, Range 25 West of the 5th P.M., Colfax Township, Boone County, Iowa, consisting of 2.00 acres.

PIN 08 8325 10 12 50 001 DESCRIBED as Outlot 'A' Clear Creek Commons 2<sup>nd</sup> Addition, a part of Parcel "A" in the Northwest 1/4 of the Northeast 1/4 of Section 10, township 83 North, Range 25 West of the 5th P.M., Colfax Township, Boone County, Iowa, consisting of 0.46 acre.

PIN 08 8325 10 11 50 014 DESCRIBED as Lot 9 Clear Creek Commons Subdivision in the Northeast 1/4 of the Northeast ¼ of Section 10, Township 83 North, Range 25 West of the 5th P.M., Colfax Township, Boone County, Iowa, consisting of 1.78 acres.

WHEREAS, at certain times it is necessary to clarify or change the Official Zoning Map and the text component of the Zoning Ordinance in order to make regulations more proficient in addressing issues of growth and desires of the citizens. It is also necessary to clarify the ordinance to make it organized and easier to understand.

WHEREAS, Todd Rueter, Rueter Corp., applied for the rezoning of 4.24 acres land located with Clear Creek Commons 2<sup>nd</sup> Addition and Clear Creek Commons Subdivision located approximately 7.5 miles east of the City of Boone. The site is located in NW 1/4 NE 1/4 and NE 1/4 NE 1/4 Section 10-83N-25W, Colfax Township, County of Boone.

WHEREAS, Lot 1 consisting of 2.0 acres shall be rezoned from A-1 (Agricultural Conservation District) to C-1 (General Commercial District) within Clear Creek Commons 2nd Addition in order to accommodate the construction of an indoor sports facility. Outlot 'A' consisting of 0.46 acre shall be rezoned from A-1 (Agricultural Conservation District) to C-1(General Commercial District) within Clear Creek Commons 2<sup>nd</sup> Addition in order to accommodate the construction of a Right-of-Way. See \*Exhibit A.

WHEREAS, Lot 9 consisting of 1.78 acres shall be rezoned from I-1(Light Industrial District) to C-1 (General Commercial District) within Clear Creek Commons Subdivision in order to accommodate the construction of a parking lot. See Exhibit A.

WHEREAS, the Zoning Commission held a public hearing on Monday, November 24, 2014 in accordance with Iowa Code. The Chairman of the Zoning Commission did forward a Final Report to the Boone County Board of Supervisors recommending approval of Todd Rueter, Rueter Corp's petition to rezone 2.46 acres from A-1 Agricultural Conservation District to C-1 General Commercial District of Clear Creek Common 2<sup>nd</sup> Addition and 1.78 acres from I-1 Light Industrial District to C-1 General Commercial District of Clear Creek Commons Subdivision in order to accommodate the construction of an indoor sports facility with parking lot.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF BOONE COUNTY, IOWA AS FOLLOWS:

SECTION ONE: That Boone County shall and hereby approves an amendment to the Official Zoning Map. Property shall be rezoned from A-1 Agricultural Conservation District to C-1 General Commercial District and I-1 Light Industrial District to C-1 General Commercial District. See \*Exhibit A.

**SECTION TWO:** Approval with the following conditions: None.

**SECTION THREE:** That this amendment shall be in full force and effect from and after its passage and approval in the manner provided by law.
