Ordinance amending the official Zoning Map of Boone County for Jacob Kraayenbrink from A-1 to A-2 on approximately 5 acres.

Legal Description: PARCEL A OF THE NE ¼ OF THE NE ¼ OF JACKSON TOWNSHIP SECTION 12 TOWNSHIP 84 NORTH, RANGE 25 WEST OF THE 5TH PM, BOONECOUNTY, IOWA.

WHEREAS, in this case, Jacob Kraayenbrink initiated a petition to rezone the property described hereinabove from A-1 (Agricultural Conservation) to A-2 (Agricultural Business) to accommodate the use of their existing buildings for business purposes.

WHEREAS, The Director of Planning and Development has forwarded a recommendation for approval from the Boone County Zoning Commission with no conditions, and

WHEREAS, findings of facts show that the property is currently Agricultural in use and surrounding properties are zoned Agricultural and they wish to establish their business on the property adjacent to their family home, and

WHEREAS, The Zoning Commission has held a public hearing in accordance with the Iowa Code. The Zoning Commission, with a unanimous vote, recommended approval of the petition by the Board of Supervisors with no conditions, and

WHEREAS, the Kraayenbrinks have previously received approval for a land division of Parcel A to be rezoned,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF BOONE COUNTY, IOWA AS FOLLOWS:

SECTION ONE: That Boone County shall, and it does hereby, approve an amendment to

the Official Zoning Map for Parcel A of the property known as 2388 170th St, Boone County, Iowa.

And that it be rezoned from A-1 Residential to A-1 Agricultural.

SECTION TWO: Approval with the following conditions, 1. none

SECTION THREE: That this amendment shall be in full force and effect from and after its passage and approval in the manner provided by law.
