RESOLUTION FIXING DATE FOR A MEETING ON THE AUTHORIZATION OF A LOAN AGREEMENT AND THE ISSUANCE OF NOT TO EXCEED \$1,256,480 LANDFILL REVENUE CAPITAL LOAN NOTES, OF BOONE COUNTY, STATE OF IOWA, AND PROVIDING FOR PUBLICATION OF NOTICE THEREOF

Whereas, it is deemed necessary and advisable that Boone County, State of Iowa, should provide for the authorization of a Loan Agreement and the issuance of Landfill Revenue Capital Loan Notes, in the amount of not to exceed \$1,256,480, as authorized by Sections 331.402 and 331.464, Code of Iowa, as amended, for the purpose of providing funds to pay costs as hereinafter described; and

Whereas, the Loan Agreement and Notes shall be payable solely and only out of the net earnings of the Landfill Enterprise of the County and shall be a first lien on the future net earnings of the Landfill Enterprise; and shall not be general obligations or be payable in any manner by taxation and the County shall be in no manner liable by reason of the failure of the net revenues to be sufficient for the payment of the Loan Agreement and Notes; and

Whereas, before a Loan Agreement may be authorized and Landfill Revenue Capital Loan Notes, issued to evidence the obligation of the County there under, it is necessary to comply with the provisions of the Code of Iowa, as amended, and to publish a notice of the proposal and of the time and place of the meeting at which the Board proposes to take action for the authorization of the Loan Agreement and Notes and to receive oral and/or written objections from any resident or property owner of the County to such action.

Now, therefore be is resolved by the Board of Supervisors of Boone County, Iowa

Section 1. That this Board meet in the Board Room, County Courthouse, 201 State Street, Boone, Iowa, at 10:00 o'clock A.M., on the 26th day of August, 2015, for the purpose of taking action on the matter of the authorization of a Loan Agreement and the issuance of not to exceed \$1,256,480 Landfill Revenue Capital Loan Notes, to evidence the obligations of the County there under, the proceeds of which will be used to provide funds to pay the costs of improving, extending and equipping the Landfill Enterprise, including acquisition of a compactor, and refunding outstanding Landfill Revenue indebtedness, including the Lease Purchase Agreement (Shredder and Excavator), dated April 16, 2012.

Section 2. The Auditor is authorized and directed to proceed on behalf of the County with the negotiation of terms of a Loan Agreement and the issuance of Landfill Revenue Capital Loan Notes, to a principal amount of not to exceed \$1,256,480, to select a date for the final approval thereof, to cause to be prepared such notice and sale information as may appear appropriate, to publish and distribute the same on behalf of the County and this Board and otherwise to take all action necessary to permit the completion of a loan on a basis favorable to the County and acceptable to the Board.

Section 3. That the Auditor is hereby directed to cause at least one publication to be made of a notice of the meeting, in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circulation in the County. The publication to be not less than four clear days nor more than twenty days before the date of the public meeting on the issuance of the Notes.

Section 4. The notice of the proposed action shall be in substantially the following form:

PUBLIC NOTICE is hereby given that the Board of Supervisors of Boone County, State of Iowa, will hold a public hearing on the 26th day of August, 2015, at 10:00 o'clock A.M., in the Board Room, County Courthouse, 201 State Street, Boone, Iowa, at which meeting the Board proposes to take additional action for the authorization of a Loan Agreement and the issuance of not to exceed \$1,256,480 Landfill Revenue Capital Loan Notes, in order to provide funds to pay the costs of improving, extending and equipping the Landfill Enterprise, including acquisition of a compactor, and refunding outstanding Landfill revenue indebtedness, including the Lease Purchase Agreement (Shredder and Excavator), dated April 16, 2012.
