A. Heather Bombei, IDPH Regional Health Department Representative, reviewed the following items in her update:

FY19 Summary of Utilization of Local Public Health Service Contract Funding in Boone County

- Contract = \$65,075
- Activities paid for from these funds in FY19:
 - ✓ 52% -- Skilled Nursing Visits (1:1 home visits for acute nursing needs) (45% in FY18)
 - √ 48% -- Home Care Aide Services (1:1 personal or environmental care to persons in own home) (55% in FY18)

FY20 = \$64,905 (there is again a 3% hold in case of budget cuts)

Review of Chapter 137 and IAC Chapter 77, Chapters 21 & 22

- Ch. 137 gives power to Local Boards of Health
- Ch. 77 requires BOH Minutes submitted to IDPH
- Ch. 21 & 22: Open Meeting Laws (aka Sunshine Laws)
