VI. OPEN PUBLIC HEARING(S) AND CONSIDERATION OF APPLICATION(S)

A. Petition for Variance #2023-002 submitted by David Marburger. Mr. Marburger is requesting both a rear yard and side yard variance which would him to re-build a larger accessory structure while utilizing the existing concrete foundation.

Director Mike Salati noted that a variance was required due to the fact that the owner was planning to build a larger structure in an area which did not meet current county code.

Mr. Day is requesting a Conditional Use permit to allow for a private cemetery to be located at 657 L Ave Boone, Ia 50036.

Chairman Sam Fisher noted a private burial ground was an approved use in the A-1 (Agriculture Conservation) District with a Conditional Use Permit.

Fisher also questioned whether this would be an allowed use in the new Zoning Ordinance.

Director Mike Salati noted he did not expect a change from our current standards.

Josh Mull noted the family planned to keep the property and that the next two generations had expressed a desire to live there.

Public hearing closed by Chairman Sam Fisher at 5:40 p.m. Fisher next asked for any comments from the Board of Adjustment members.

Steve Kieffer wanted to confirm that the request was for two burial plots.

Sam Fisher stated that was correct.

Holly Kilstrom questioned whether there had been any concerns expressed by the neighbors.

Director Salati noted on neighboring farm had stopped into the office requesting information, had not expressed concerns.
