The Board led the Pledge of Allegiance.

Chairman Bryant called the meeting to order at 9:00 a.m. with Bryant, Kretzinger & Longhorn present.

Kretzinger moved Longhorn seconded motion to approve the agenda as posted. All ayes. Motion carried.

Pursuant to Iowa Code 21.5 (i) – “To evaluate the professional competency of an individual whose appointment, hiring, performance, or discharge is being considered when necessary to prevent needless and irreparable injury to that individual’s reputation and that individual requests a closed session” Kretzinger moved Longhorn seconded motion to go into closed session. All Ayes, Motion carried and Board of Supervisors then entered into closed session at 9:02 a.m.

Board of Supervisors resumed open session at 9:29 a.m.

Longhorn moved Kretzinger seconded motion to approve the following items on the CONSENT AGENDA: previous meetings minutes; approved resignation of Bryan Olmstead, Sheriff’s Department, effective March 17, 2025; approved resignation of Adam Choat, Sheriff’s Department, effective March 17, 2025; approved waiving of tipping fee for 2 loads of municipal solid waste for City of Rippey for June 26-30, 2025; approved signing 2025 Applications for Homestead, Military & Disabled Veterans Property Tax Credits & Exemptions as recommended by the Boone County Assessor (a complete list can be found on the Boone County website), approved signing updated Assured Partners Contract; approved signing Solutions 25-26 Agreement; secondary road claims #29443 to #29466 and other county claims #177287 to #177367 totaling \$358,911.57 and issuance of warrants #94154 to #94250 in payment of the same. Motion carried. Ayes: Longhorn and Bryant. Nays: Kretzinger.

Gary Nystrom, Conservation Board Chair and Chelsie Wilson, Conservation Director were present to discuss/give update of Don Williams Club House project. Nystrom confirmed there will NOT be a full kitchen in the new building, but WILL be a prep area for simple concessions – just as the old/existing building has but without a stove.

Diane Patrick, County Auditor and Katie Moran, Deputy County Auditor were present to discuss membership to the Iowa Drainage District Association. Kretzinger moved Longhorn seconded motion to table this item pending more information. All Ayes. Motion carried.

Steve Cunningham, Veterans Affairs Director was present for a Quarterly Update

Longhorn moved Kretzinger seconded motion to adjourn the meeting. All ayes. Motion carried. Chairman Bryant adjourned the meeting at 10:55 a.m.
