The Board led the Pledge of Allegiance.

Chairman Bryant called the meeting to order at 9:02 a.m. with Bryant, Kretzinger & Longhorn present.

None absent.

Longhorn moved, Kretzinger seconded motion to approve the agenda as posted. All ayes. Motion carried.

Chairman Bryant asked if there were any questions or items to be removed from the Consent Agenda; no requests made. Kretzinger moved, Longhorn seconded motion to approve the following items on the CONSENT AGENDA: September 17, 2025 meeting minutes; approval hiring Caroline Kellogg, PRN Jailer @\$25.53 per hour effective September 22, 2025; approval of Pay Adjustment for Tara Breon, Engineers Office to \$34.80 per hour effective October 3, 2025 for 4 year step as Assistant to the Engineer I; approval of Application for Class C Retail Alcohol license & Outdoor service for Eagle's Ledge LLC; placing on file Recovery Fines collected for Boone, Calhoun, Greene, and Sac Counties for August 2025; approval to rescind and abate taxes for Tax Years 2017-2026 on Mobile Home, VIN 68A14689 owned by Dolan Olson; approval of Fireworks Display permit from J&M Displays, Inc for a wedding reception at 1411 160th St., Boone, IA on October 11, 2025; approval of Secondary Roads claims #29737 to #29753 and other county claims #178412 to #178460 totaling \$265,608.79 and issuance of warrants #96673 to #96730 in payment of the same, drainage claim #1211 totaling \$61,48.57 and issuance of drainage warrants #1591 to #1603 in payment of the same. Chelsie Wilson, Conservation Director made a request to consider reallocation of funds for a position at the Golf Course Clubhouse to finish the season. Longhorn moved Kretzinger seconded motion to reallocate conservation funds from lease funding to payroll with the Conservation Board approving amounts and setting hours for any employees needed to fulfill the last 18 days in the 2025 Season. All Ayes. Motion carried.

Kretzinger moved Longhorn seconded motion to adopt the presented income and expense spreadsheet showing sufficient E911 funding/income to meet expenses for FY2026 even with the potential \$24,000 increase in payments to the state, and to share said spreadsheet with E911 Board. All Ayes. Motion carried.

Supervisors discussed Fire Flow investment at Hwy 17 & 30. Kretzinger moved Longhorn seconded to not invest in a water expansion at this location at this time. All Ayes. Motion carried.

Longhorn moved Kretzinger seconded motion to adjourn the meeting. All ayes. Motion carried. Chairman Bryant adjourned the meeting at 9:55 a.m.
