Ondrea Elmquist, City of Boone Administrator was present to discuss City of Boone Housing Incentive Program.

Andy Godzicki, County Sheriff was present to discuss using jail rent funds for jail updates to floor, work stations & welding projects. Longhorn moved Bryant seconded motion to allow Sheriff a budget amendment of up to \$75,000 of jail rent funds to be used for jail projects. All ayes. Motion carried.
