

Notice of City-School Election

Notice is hereby given to the eligible electors in the County of Boone, State of Iowa, that the City-School Election will be held on Tuesday, November 4, 2025, for the purpose of electing candidates for city, community school district, and area school offices. Some jurisdictions are holding special elections for public measures in conjunction with the City-School Election.

Optical Scan Equipment will be used to count the votes cast. Public Testing of all equipment will be held in the Conference room of the Boone County Human Services Building located at 900 W Mamie Eisenhower Ave., beginning at 9:00 a.m. on Tuesday, October 21, 2025 and will continue until finished.

The polls will open at 7:00 AM and will close at 8:00 PM, the polling locations are listed below.

Any voter who is physically unable to enter a polling place has the right to vote in the voter's vehicle. For further information, please contact the County Auditor's office at 515-433-0502 or by email at boonecoaud@boonecounty.iowa.gov. For TTY access, dial 711+ (515) 433-0502.

Pre-registered voters are required to provide an approved form of identification at the polling place before receiving and casting a regular ballot. Voters who are not pre-registered – such as voters registering to vote on election day – and voters changing precincts must also provide proof of residence. A voter who is unable to provide an approved form of identification (or prove residence if required) 1) may have the voter's identity/residence attested to by another registered voter in the precinct, 2) prove identity and residence using Election Day Registration documents, or 3) cast a provisional ballot and provide proof of identity/residence at the county auditor's office by 12:00pm noon on Monday, November 10th, 2025. Election Day Registrant attestors must provide an approved form of identification. Absentee ballots are available for in-person absentee voting in the County Auditor's office during regular business hours, 8:00 a.m. - 4:30 p.m., Monday – Friday, until Monday, November 3, 2025. Voters may check the status of their absentee ballot by contacting the Boone County Auditor's Office or online at www.sos.iowa.gov/elections/absenteeballotstaus/search.

All ballots include races for a community school district. Ballots for voters residing in incorporated cities also have city races. Ballots for Gilbert Community School District, Ogden Community School District, South Hamilton School District, Woodward-Granger Community School District, City of Slater, and Iowa Central Community College include public measures. PUBLIC MEASURES BY DESIGNATION AND JURISDICTION

Public Measure TP – Physical Plant and Equipment Levy for Gilbert Community School District

Shall the Board of Directors of the Gilbert Community School District, in the Counties of Story and Boone, State of Iowa, for the purpose of purchasing and improving grounds; constructing schoolhouses or buildings and opening roads to schoolhouses or buildings; purchasing of buildings; purchase, lease or lease-purchase of technology and equipment; paying debts contracted for the erection or construction of schoolhouses or buildings, not including interest on bonds; procuring or acquisition of libraries; repairing, remodeling, reconstructing, improving, or expanding the schoolhouses or buildings and additions to existing schoolhouses; expenditures for energy conservation; renting facilities under Iowa Code Chapter 28E; purchasing transportation equipment for transporting students; lease purchase option agreements for school buildings or equipment; purchasing equipment authorized by law; or for any purpose or purposes now or hereafter authorized by law, be authorized for a period of ten (10) years, levy annually, a voter-approved physical plant and

equipment property tax not exceed One Dollar Thirty-Four Cents (\$1.34) per One Thousand Dollars (\$1,000) of assessed valuation of the taxable property within the school district commencing with the levy for collection in the fiscal year ending June 30, 2029, or each year thereafter?

Public Measure BR – Revenue Purpose Statement for Ogden Community School District

Summary: To adopt a Revenue Purpose Statement specifying the use of revenues the Ogden Community School District will receive from the State of Iowa Secure an Advanced Vision for Education Fund.

In the Ogden Community School District, the following Revenue Purpose Statement which specifies the use of revenues the Ogden Community School District will receive from State of Iowa Secure an Advanced Vision for Education Fund shall be adopted.

- To provide funds to acquire or install information technology infrastructure (including improving buildings or sites for the purpose of accessing broadband digital telecommunications) and school safety and security infrastructure.
- To provide funds to build and furnish a new school building or buildings; to build and furnish addition(s) to school buildings in the District; to remodel, reconstruct, repair, expand, and improve the school buildings in the District; to purchase and improve grounds; for demolition work; to furnish and equip district facilities.
- To provide funds for the purchase, lease or lease-purchase of buildings, equipment (including transportation and recreation equipment), or technology and to repair transportation equipment for transporting students as authorized by law, to implement energy conservation measures, sharing or rental of facilities including a joint infrastructure project for the purposes of offering classes under district-to-community college programs as authorized in Iowa Code Section 423F.3(3)(c), procuring or acquisition of libraries, or opening roads to schoolhouses or buildings.
- To provide funds to purchase land as part of start-up costs for new student construction program or if the sale of the previous student construction was insufficient to purchase land, and to purchase construction materials and supplies for a student-constructed building or shed intended to be retained by and used by the District.
- To provide funds to make payments to a municipality or other entity as required under Iowa Code Section 403.19(2).
- To provide funds for demolition, cleanup, and other costs if such costs are necessitated by, and incurred within two years of, a disaster.
- To provide funds for radon testing and mitigation.
- To provide funds to establish and maintain public recreation places and playgrounds; provide for supervision and instruction for recreational activities; or for community education purposes.
- To provide funds for the payment of principal and interest or retirement of general obligation bonds issued for school infrastructure purposes, energy improvement loans, loan agreements authorized by Iowa Code Section 297.36, sales, service and use tax revenue bonds issued under Iowa Code Section 423E.5 or Iowa Code Section 423F.4.
- To provide funds for property tax relief; and
- To provide funds for other authorized expenditures and purposes as now or hereafter permitted by law and designated by the Ogden Community School District.
- It being understood that if this public measure should fail to be approved by the voters, such failure shall not be construed to terminate or restrict authority previously granted by the votes to expend receipts from the Secure an Advanced Vision for Education Fund.
- If approved, the Revenue Purpose Statement shall remain in effect until replaced or amended by the Ogden Community School District.

Public Measure BQ – Physical Plant and Equipment Levy for Ogden Community School District

Shall the Board of Directors of the Ogden Community School District, in the County of Boone, State of Iowa, for the purpose of purchasing and improving grounds; constructing schoolhouses or buildings and opening roads to schoolhouses or buildings; purchasing of buildings; purchase, lease or lease-purchase of technology and equipment; paying debts contracted for the erection or construction of schoolhouses or buildings, not including interest on bonds; procuring or acquisition of libraries; repairing, remodeling, reconstructing, improving, or expanding the schoolhouses or buildings and additions to existing schoolhouses; expenditures for energy conservation; renting facilities under Chapter 28E; purchasing transportation equipment for transporting students; lease purchase option agreements for school buildings or equipment; purchasing equipment authorized by law; or for any purpose or purposes now or hereafter authorized by law, be authorized for a period of ten (10) years, to levy annually, a voter-approved physical plant and equipment property tax not to exceed One Dollar Thirty-Four Cents (\$1.34) per One Thousand Dollars (\$1,000) of the assessed valuation of the taxable property within the school district commencing with the levy for collection in the fiscal year ending June 30, 2029, or each year thereafter?

Public Measure JB – Physical Plant and Equipment Levy for South Hamilton Community School District

Shall the Board of Directors of the South Hamilton Community School District, in the Counties of Hamilton and Boone, State of Iowa, for the purpose of purchasing and improving grounds; constructing schoolhouses or buildings and opening roads to schoolhouses or buildings; purchasing of buildings; purchase, lease or lease-purchase of technology and equipment; paying debts contracted for the erection or construction of schoolhouses or buildings, not including interest on bonds; procuring or acquisition of libraries; repairing, remodeling, reconstructing, improving, or expanding the schoolhouses or buildings and additions to existing schoolhouses; expenditures for energy conservation; renting facilities under Iowa Code Chapter 28E; purchasing transportation equipment for transporting students; lease purchase option agreements for school buildings or equipment; purchasing equipment authorized by law; or for any purpose or purposes now or hereafter authorized by law, be authorized for a period of ten (10) years, to levy annually, a voter-approved physical plant and equipment property tax not to exceed One Dollar (\$1.00) per One Thousand Dollars (\$1,000) of the assessed valuation of the taxable property within the school district commencing with the levy for collection in the fiscal year ending June 30, 2028, or each year thereafter?

Public Measure FP – Physical Plant and Equipment Levy for Woodward-Granger Community School District

Shall the Board of Directors of the Woodward-Granger Community School District, in the Counties of Dallas, Polk and Boone, State of Iowa, for the purpose of purchasing and improving grounds; constructing schoolhouses or buildings and opening roads to schoolhouses or buildings; purchasing of buildings; purchase, lease or lease-purchase of technology and equipment; paying debts contracted for the erection or construction of schoolhouses or buildings, not including interest on bonds; procuring or acquisition of libraries; repairing, remodeling, reconstructing, improving, or expanding the schoolhouses or buildings and additions to existing schoolhouses; expenditures for energy conservation; renting facilities under Iowa Code Chapter 28E; purchasing transportation equipment for transporting students; lease purchase option agreements for school buildings or equipment; purchasing equipment authorized by law; or for any purpose or purposes now or hereafter authorized by law, be authorized for a period of ten (10) years, to levy annually, a voter-approved physical plant and equipment property tax not to exceed One Dollar Thirty-Four Cents (\$1.34) per One Thousand Dollars (\$1,000) of the assessed valuation of the taxable property within the school district commencing with the levy for collection in the fiscal year ending June 30, 2029, or each year thereafter?

Public Measure TQ – Local Option Sales and Services Tax for City of Slater

Summary: To authorize a change in the use of the one percent (1%) local sales and services tax in the City of Slater effective July 1, 2026.

The use of the one percent (1%) local option sales and services tax shall be changed in the City of Slater effective July 1, 2026.

PROPOSED USES OF THE TAX:

If the change is approved, revenues from the sales and services tax shall be allocated as follows: 10% for property tax relief.

The specific purposes for which the revenues shall otherwise be expended are:

90% for any lawful purpose including but not limited to city hall facilities, community center facilities, library facilities, other capital projects, retirement of debt incurred for any such purposes, and any other lawful purpose.

CURRENT USES OF THE TAX:

Revenues from the sales and services tax are currently allocated as follows: 100% for property tax relief.

Public Measure VT – General Obligation Bond for Iowa Central Community College

Shall the Board of Directors of the Iowa Central Community College in the Counties of Boone, Buena Vista, Calhoun, Carroll, Cherokee, Clay, Crawford, Franklin, Greene, Hamilton, Hancock, Humboldt, Ida, Kossuth, Palo Alto, Pocahontas, Sac, Webster and Wright, State of Iowa, be authorized to contract indebtedness and issue General Obligation bonds to provide funds to remodel, improve, repair, construct, erect, furnish, and equip buildings and additions to buildings for educational and workforce training, to make improvements to sites and acquire land, to contract indebtedness therefore, and issue its school bonds in an amount not exceeding \$35,000,000 for those purposes?
